Setup personnel will have the final authority as to the parking and placement of exhibits. **ALL** exhibits will be exposed to weather conditions, there is no covered area and no power service provided. Exhibits may not be left running unattended and the site will be left clean by exhibitor.

**Exhibits will be supervised from 10 am- 6:30 pm Saturday May 6<sup>th</sup>, 2023.**

Exhibits that need cover/ storage before or after the show may be transported to a neighbor's farm/barn, coordinate with Jacque Duyck Jones 503.977.0209
